License application fees collected by North Carolina are listed below, however, there is also a \$5.00 transaction fee for each resident NIPR electronic application submission in addition to below listed fees.

<p>*Below Producer license types have one \$50 application processing fee per application. Multiple Producer Lines of authority (LOA) on one application would be an additional \$50 registration fee only per LOA.</p> <p>Fingerprint fee – If a fingerprint fee is indicated, it is only required for the first initial producer license. Subsequent additions to LOA do not require fingerprint submission and will not incur this fee unless there are certain lapses of licensure. Please see footnote.</p>

Reinstatement license applications must be submitted within one year of license lapse date for all license types except Surplus Lines which is two years, otherwise initial license application fees above apply.
