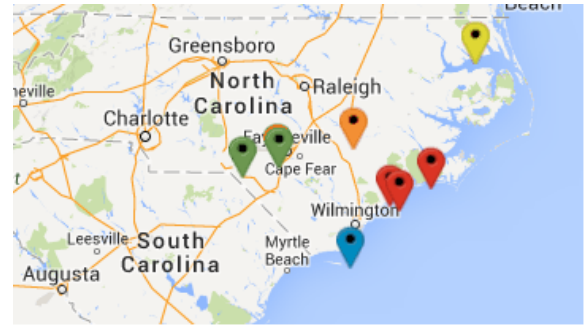


## North Carolina Code Officials Qualification Board (NCCOQB) Information for Military Service members, veterans and spouses.

Thank you for your service!

North Carolina is a military friendly state with installations representing all service as shown in the insert map. While the NCCOQB regulations allow for reciprocity, the board acknowledges this may not be an option for members of the military and their spouses who frequently relocate.



The Board also recognizes that some military education, training, testing and duty assignments – as evidenced by Military Occupational Specialties designations that may be unique to each service – are equivalent to education and experience required to perform inspection duties as code enforcement officials in North Carolina.

**Coast Guard** - National Strike Force - Air Station Elizabeth City

**Marine** - Cherry Point – Havelock, Camp Lejeune – Jacksonville, MCAS New River – Jacksonville

**Army** - Fort Bragg – Fayetteville, Camp Mackall – Southern Pines

**Navy** - Military Ocean Terminal – Sunny Point

**Air Force** – Seymour Johnson – Goldsboro, Pope – Fayetteville

**National Guard & Reserve Components (All Branches)** – Multiple units across the state.

### MILITARY SERVICE MEMBERS

**NC General Statute § 93B-15.1(a)** requires state occupational licensing boards to allow applicants for licensure to lawfully practice the applicant’s occupation in North Carolina, upon application to the board, provided the applicant satisfies the following conditions:

- (1) Has been awarded a military occupational specialty and has done all of the following at a level that is substantially equivalent to or exceeds the requirements for licensure of the occupational licensing board from which the applicant is seeking licensure in this State:
  - completed a military program of training
  - completed testing or equivalent training and experience
  - performed in the occupational specialty
- (2) Has engaged in the active practice of the occupation for which the person is seeking a license from the occupational licensing board in this State for at least two of the five years preceding the date of the application under this section.
- (3) Has not committed any act in any jurisdiction that would have constituted grounds for refusal, suspension, or revocation of a license to practice that occupation in this State at the time the act was committed.
- (4) Pays any fees required by the occupational licensing board for which the applicant is seeking licensure in this State.

The NCCOQB certifies code enforcement officials across that state in five technical trades: building, electrical, mechanical, plumbing, and fire prevention. The military branches have many Military Occupational Categories (MOCs) that are broadly or narrowly associated with one or more of the certification trades issued by the Board. In an effort to perform the most thorough evaluation of an applicant, staff will utilize all online resources and contact the appropriate branch of service if needed to provide a description of job duties, formal training and skill criteria.

Title 11, Chapter 8, Sections .0602 and .0706 of the North Carolina Administrative Code require an applicant must have either a high school diploma or its equivalent and meet an experience, education, or licensure requirement as listed in Section .0706. There are three different levels per trade and each level has its own experience and/or education requirements. Structures are categorized into Levels I, II and III based on occupancy classification, square footage and

### **MILITARY SERVICE MEMBER SPOUSES**

**NC General Statute § 93B-15.1(b)** requires state occupational licensing boards to allow applicants for licensure, who are military spouses, to lawfully practice the applicant's occupation in North Carolina, upon application to the board, the applicant satisfies the following conditions:

- (1) Holds a current license, certification, or registration from another jurisdiction, and that jurisdiction's requirements for licensure, certification, or registration are substantially equivalent to or exceed the requirements for licensure, certification, or registration of the occupational licensing board for which the applicant is seeking licensure, certification, or registration in this State.
- (2) Can demonstrate competency in the occupation through methods as determined by the Board, such as having completed continuing education units or having had recent experience for at least two of the five years preceding the date of the application under this section.
- (3) Has not committed any act in any jurisdiction that would have constituted grounds for refusal, suspension, or revocation of a license to practice that occupation in this State at the time the act was committed.
- (4) Is in good standing and has not been disciplined by the agency that had jurisdiction to issue the license, certification, or permit.
- (5) Pays any fees required by the occupational licensing board for which the applicant is seeking licensure, certification, or registration in this State.

(c) All relevant experience of a military service member in the discharge of official duties or, for a military spouse, all relevant experience, including full-time and part-time experience, regardless of whether in a paid or volunteer capacity, shall be credited in the calculation of years of practice in an occupation as required under subsection (a) or (b) of this section.

### **EDUCATIONAL REQUIREMENTS:**

Service members may receive military education and training that is creditable toward the college degrees noted above of Associate of Applied Science (AAS) or Bachelor of Science (BS). The American Council on Education (ACE) provides academic review of military courses and occupations. The [Joint Services Transcript \(JST\)](#) provides documentation to colleges and universities of the professional military education, training and occupation experiences for service members and veterans. The Army, Marine Corps, Navy and Coast Guard participate in this transcript program. Service members who may want the NCCOQB to consider courses for college credit should provide their JST to an appropriate college, university, community or technical college for evaluation. Members of the Air Force may provide transcripts from the Air Force University or Community College of the Air Force. The NCCOQB will review the final determination on college degree awarded by the academic institution.

### **EXPERIENCE REQUIREMENTS:**

Documentation of experience and MOC assignment will be required. You will need to provide a **DD 214, Certificate of Release or Discharge from Active Duty**. This form typically includes the primary specialty number, title and years and months in specialty, military education, and, indication of high school graduation or equivalent.

### **CONSTRUCTION AND TRADE EXPERIENCE THAT MAY BE APPLICABLE TO CERTIFICATION:**

The MOCs and military training that relate to construction, fire prevention or fire suppression are listed below. The NCCOQB notes there are many military to civilian transition programs that seek to match skills practiced in the military with civilian occupations. Typically the Military Occupational Specialty is matched or "crosswalked" to federal job classification systems such as the U.S. Dept. of Commerce and Census Bureau North American Industry Classification System (NAICS) that lists inspection services under 54135 Building Inspection services; the U.S. Bureau of Labor Statistics Standard Occupational Classification (SOC) 47-4011 Construction and Building Inspectors or O\*NET (Occupational Information Network).

**IMPORTANT:** The list below is sorted alphabetically by service branch and MOC. Some of the MOCs listed below relate to construction, but do not include construction duties that are involved in the construction, design, installation or inspection of a building or building system. As an example, horizontal construction involves moving tons of earth and other materials in preparing the site for the completion of roadways, bridges, and culvert. This MOC involves the use of heavy earth-moving machinery but doesn't apply to any construction component of a building as applicable to the NC State Building Codes. At minimum, further investigation would be required to assess the skill criteria and training the individual received when assigned to the MOC.

During the review process, efforts will be made to give appropriate credit for experience and/or education as it applies to the Board's rules and the utilization of construction and installation practices. Staff will update the list below periodically as changes in the military or the Board's rules occur. If an MOC is missing, staff will contact the branch of service directly to assess the training and education background to determine certification eligibility.
