- **1.3g Pyrotechnic Operator**: –Large scale Fireworks, large professional fireworks used in public displays such as theme parks, baseball games, concerts, 4th of July displays. (ATF Clearance Required)
- **1.4g Pyrotechnic Operator**: Lower grade Fireworks (consumer fireworks) that utilize pyrotechnic materials that are not legal in North Carolina, but do not require an Alcohol Tobacco Firearms and Explosives (BATFE) license to purchase. Items may include but are not limited to mortars and aerial shells 2 inches and smaller, "bottle rockets", "fire crackers", finally cakes, roman candles, and any pyrotechnic material determined to be illegal by NCGS 14-414. (No ATF Clearance Required)

**Proximate Audience** - Close shoots, a display that occurs within a building or structure or outside before and audience within 75ft of the pyrotechnics. (No ATF Clearance Required)
